About the Workshop

The genocidal war on Gaza marks a new political phase, and as such drives the development of new or modified epistemological frameworks. Genocide generates new perspectives on the boundaries of the settler-colonial project, its mechanisms, underlying motives, and objectives, as well as its reversion to Nakba-like practices through the physical annihilation of Palestinians and the destruction of the basic foundations of Palestinian existence.

It also reopens questions concerning the citizenship for Palestinians inside the Green Line, their relationship with the Jewish state, and the state of the broader Palestinian political arena, including inside the Green Line.

The workshop aims to provide critical readings of literature produced by Palestinian and international intellectuals and academics on the genocidal war in Gaza. It also seeks to develop new theoretical research agendas by critiquing the existing literature and its approaches to the new reality in historical Palestine, including works that address the Zionist project, the situation of the Palestinians, and the relationship between the two.
